It proposes a model, the TrustInside(r) which is a Trust Barometer, applicable in two forms: (1) As a large-scale survey and survey tool and (2) As an individual and collective support tool. It is currently involved in projects such as: Trust as a key success factor in the reform of Education in Ukraine; Partnership with an international organization for a train-the-trainer programs on "assessing and building Trust" in three countries; Improving trust relationships between banks and small businesses as a key to economic growth; Assessing trust/distrust in the prevention of radicalization in a French locality.
